## Terms of Service:

The following terms and conditions govern all use of the studyregular.in website and all content, services and products available at or through the website (taken together, the Website). The Website is owned and operated by Study Regular ("Study Regular"). The Website is offered subject to your acceptance without modification of all of the terms and conditions contained herein and all other operating rules, policies (including, without limitation, Study Regular Privacy Policy) and procedures that may be published from time to time on this Site by Study Regular (collectively, the "Agreement").

Please read this Agreement carefully before accessing or using the Website. By accessing or using any part of the web site, you agree to become bound by the terms and conditions of this agreement. ## Privacy Policy:

Study Regular ("**Study Regular**") operates studyregular.in and may operate other websites. It is Study Regular policy to respect your privacy regarding any information we may collect while operating our websites.

### Website Visitors

Like most website operators, Study Regular collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Study Regular purpose in collecting non-personally identifying information is to better understand how Study Regular visitors use its website.
